19. PUBLIC COMMENTS

- Dr. Fuchs read a statement concerning the bomb scare which occurred on April 23 in the midst of Jefferson Township HS/MS transportation. She acknowledged there was room for improvement. Dr. Fuchs invited interested individuals to serve on a stakeholders group on May 24 to discuss security strategy.
- A comment was raised regarding the lockdown two weeks ago. It was explained that the initial thought was that intruders had entered the facilities. It was later determined that it was students in unauthorized areas.
- Several parents commented on concerns and ideas they have regarding improved communication.
- A question was raised regarding absences and suspensions that some students received as a result of the bomb scare.
- The idea to activate the phone chain was well received and it was suggested age appropriate drills be performed throughout the district.
- Lt. Wilsusen discussed this event from a police perspective and clarified some misconceptions.
- Several Board Members commented on the amount of community input. It was noted that improvements to emergency plans is an evolving process.
